

## 2020 APAS ELECTION REPRESENTATIVE NOMINATION and CANDIDATE ACCEPTANCE

On November 9, 2020, the Agricultural Producers Association of Saskatchewan (APAS) will elect individuals to represent each participating Rural Municipality. APAS elections are managed independently by APAS but take place at the same time as municipal elections.

Elected APAS Representatives will represent the APAS members in their RM by participating in APAS governance and supporting the development of agricultural policy, research, and advocacy. Terms are four (4) years, commencing upon certification of the election. **For a complete APAS Representative job description, visit apas.ca/elections.** 

As per the APAS Bylaws, all nominees must meet the following requirements:

- □ Is an individual member of APAS, defined as an individual that:
  - is engaged in the Business of Farming or is the owner of agricultural land located in a participating RM
  - o is a citizen of Canada
  - is a resident of Saskatchewan
  - $\circ$  is at least 18 years of age
- Has not been found to be of unsound mind by any court
- Does not have the status of a bankrupt
- □ Is not an employee of APAS
- □ Has remitted their property taxes to the participating RM
- Commits to support the objectives of APAS in good faith and to work in the best interests of the organization and its members
- Be nominated by two (2) ratepayers in the participating RM
- Be willing to represent the participating RM for a term of four (4) years, commencing upon certification of the election
- **Submit BOTH PAGES of this completed form directly to APAS no later than October 7<sup>th</sup>, 2020.**
