Sitting on a tractor putting in the crop gives a person time to think and reflect on the past year. The May 28, 2015 Government of Saskatchewan Crop Report noted that 87 per cent of the crop has been seeded, well above last year’s level of 64 per cent and significantly above the five year average of 61 per cent. Last year almost everyone was faced with saturated soils and although some of us on the east side of the province continue to face excessive moisture during seeding, as I write this introduction, many areas of Saskatchewan have experienced a 180 degree swing in the growing season from 2014.

On the west and south central side of the province many farmers have sown their crop and are looking to the skies for some rain to germinate their seed. Pastures and hay land remain brown and the grass crunches underfoot. Ranchers will be using their hay supply or looking to purchase feed to supplement spring feeding. A ban has been issued on all open fires for all provincial forests and for all provincial parks and recreation sites located within those forests.

Some crops had germinated in early May and emerged in a few short days, a deep frost occurred and reseeded is underway. Last week’s frost, although not as cold, was widespread and will further impact many crops. What a difference 12 months can make.

As farmers and ranchers, we deal with the present, hope and plan for the best, and will adapt as required to ensure the success of our farming operation over the longer term. Above all else, as we enter the 2015 production year, please stay safe, remain confident about your skills and abilities, continue to be an optimist, and enjoy your family and neighbours.
